



Lavender Purple **CRUSH**[™] Multi-Purpose Cleaner

Directions: Add 2-3 oz. (60-90mL) to one gal. of water. Spray on and wipe off or apply with mop, sponge or scrubber. No rinsing required. When used as directed, it is gentle enough for fabrics, carpeting & upholstery. For carpet & fabric, test on hidden area for color fastness before use.
