2. Dilute 8 oz. (237 mL) of Pre-Spray Cleaner to 1 gallon (3.78 L)
3. Spray solution on carpet to be cleaned.
4. For best results, agitate with a carpet rake.
5. All 5-10 minutes of dwell time, DO NOT allow pre-spray to dry before extracting.
6. Clean in the usual manner.
7. Vacuum thoroughly when dry.

NOTE: Freezing will not affect cleaning power. Thaw, shake well and use.
