## WATER SOLUBLE DEODORIZER

Odor-Bane<sup>2</sup> is a highly effective deodorizer that neutralizes odors caused by smoke, vomit, urine, etc., and leaves a fresh, pleasant fragrance in any room. Can also be fogged, sprayed or used during routine cleaning procedures.

Shake well before using.

**For Carpet and Upholstery Deodorizing:** Add 1 oz. (30 mL) of Odor-Bane<sup>2</sup> to a quart (liter) of water. May be sprayed or fogged. Avoid excessive breathing of spray mist. Eye protection and mist filter mask should be used for large scale spraying or fogging. **When used during cleaning:** Add 1/2 to 1 oz. (15-30 mL) of Odor-Bane<sup>2</sup> to each gallon (3.78 L) of stock solution. Certified Odor-Bane<sup>2</sup> is compatible with all Certified shampoos and extraction cleaners. **When mopping:** Add 2-4 oz. (60-118 mL) of Odor-Bane<sup>2</sup> per gallon (3.78 L) of cleaner/disinfectant solution. Severe malodors may require more.

Do not handle until all safety precautions have been read and understood. **KEEP OUT OF REACH OF CHILDREN. READ LABEL BEFORE USE. FOR PROFESSIONAL USE ONLY. If Ingested: Do NOT induce vomiting. Wash out mouth thoroughly. Immediately call a POISON CENTER or physician. If on skin: Gently wash with plenty of soap and water. If skin irritation occurs, get medical attention immediately. **IN CASE OF FIRE:** Use water spray, foam, dry chemical powder, or carbon dioxide. NOTE: Freezing will not affect cleaning power. Thaw, shake well and use. **Storage & Disposal:** Do not store above 120°F for extended periods. Keep container tightly closed in a cool, well ventilated place away from direct sunlight.
